1. The regular Promotion of the above official(s) will take effect from the date on which he/she assumes the charge of promotional post. While accepting promotion, the concerned official(s) may please keep in mind that they have been offered in-situ promotion; however, their transfer orders will be issued in due course under the AGT policy.
2. The above official(s) shall exercise the option for fixation of pay, either from the date of promotion or from the date of next increment, within one month from the date of their promotion, as per the clause under FR 22(I)(a)(1) provided that the option for fixation of pay in the promotional post in the above manner under MACP Scheme has not been availed/exercised earlier. **The option, once exercised, will be final.**
3. The declaration regarding the acceptance/refusal of the promotion offered should be communicated by the official concerned **within 05 days from the date of issuance of this order** through the respective Controlling Authority. **In the absence of any communication, it will be presumed that he/she has not accepted the promotion and no correspondence in future will be entertained in this regard.**
4. The promotion is subject to the terms and conditions of service as applicable to the similar class of employees as laid down in the ESI Corporation (Staff and Conditions of Service Regulations, 2023, as amended from time to time.
5. The promotion of the official(s) ordered against the reserved category, if any, will be subject to satisfactory verification of their Caste Certificate from the Competent Authority concerned. **Such official(s) has/have to submit their latest Caste Certificate to this office through their respective Controlling Authority within one month of issuance of this order.**
6. The Seniority of the promoted official(s) will be determined in accordance with the order of the recommendation of the DPC.
7. Those who decline the offer of promotion will not be considered for regular

promotion for a period of one year from the date of refusal of the promotion or till a next vacancy arises whichever is later. On the eventual promotion to the higher grade, such employees will lose seniority vis-a-vis his/her juniors promoted to the higher grade earlier.

8. Promotion of the official(s) shall be subject to the final outcome of the SLP(C) No. 30621 of 2011 pending before Hon'ble Supreme Court.
