Following procedures must be followed for availing OPD / Secondary treatment / Super Speciality treatment in tie-up / empaneled hospitals:-

- a. All Staff / Officers / Pensioners will visit their respective Authorized Medical Attendant / Government Institutions of their respective areas on the first instance and

- obtain OPD / Secondary treatment there.
- b. If any medical treatment facility is not available with AMA / Government Hospital as mentioned in (a) above, the Staff / Officers / Pensioners concerned will obtain a reference letter from such AMA / ESIC hospital addressed to the empanelled hospital to the effect that the said medical treatment is not available there.
 - c. The Concerned Staff / Officers / Pensioners will have to intimate in advance to this effect in writing to The Regional Director (CRI), ESI Corporation, Ahmedabad.
 - d. The concerned Staff / Officers / Pensioners will produce the said reference letter in the above-cited tie-up hospitals. The Regional Office will confirm the reference to the said tie-up hospital by e-mail / post, on the basis of which treatment will be provided at the aforesaid hospital.
 - e. The reference letter will only be provided to Staff / Officers / Pensioners for those services entered with the respective empanelled / tie-up hospitals and available with them, since all services are not available and entered / engaged at CGHS rates with empanelled / tie-up hospitals.
 - f. In the absence of referral letter from AMA, The Regional Director / SMO may act as an AMA, if found necessary depending on case to case but this clause will be used sparingly, only in exceptional cases.
 - g. Indoor / In-Patient treatment taken in the emergent situation in any empanelled hospital irrespective of distance from their residence can be availed on production of Medical / ID cards. However, reimbursement in such cases will be subject to CGHS / CS (MA) Rules and reimbursement shall be restricted to the ceiling of CGHS / CS (MA) Rules or actual expenditure, whichever is less.
 - h. Treatment taken in the emergent situation in any non-empanelled private hospital irrespective of distance from their residence subject to condition that the hospital concerned has certified the Medical emergency and Nodal Officer in consultation with MR / SMO / MS of ESI Corporation is satisfied of the emergent condition. However, reimbursement in such cases will be made as per CGHS / CS (MA) rules approved rates or actual expenditure, whichever is less.
